JOHNS PLACE off slowly, chased the pace, moved to take over from AMANDINE in the stretch, responded when challenged by ALBANY COUNTY and was fully extended to hold that rival off. ALBANY COUNTY unhurried early, rallied along the inside to reach JOHNS PLACE at the sixteenth pole but was edged to the wire. SHIVAREE (GB) tracked the pace off the rail into the stretch and was gaining slowly on the top ones at the finish. AMANDINE showed speed off the rail, then bore out badly through the stretch run and was outfinished. STEPHIE'S CAT outrun after ducking in and being steadied at the start, closed with a belated rally. RUBY MARTINI raced four wide on the turn and failed to menace. TIGER FEVER chased the pace around the turn and gave way. APT TO BANK chased the pace three wide around the turn and tired. XTRA JET reserved after hitting the gate at the start, saved ground and faded.
